YOU MUST PASS THE EXAMINATION FOR CERTIFIED OPERATOR TO GO INTO BUSINESS FOR YOURSELF OR TO SUPERVISE THE SERVICES FROM A MAIN OFFICE. NO ONE WILL BE ALLOWED TO TAKE EXAMINATION(S) UNLESS HE OR SHE HAS: 1) BEEN PREVIOUSLY APPROVED BY THE MONTGOMERY OFFICE; 2) IS ON THE EXAM LIST, 3) HAS THE 'APPROVED LETTER' IN HAND ON EXAM DAY, OR; 4) HAS AN EXPIRED COMMERCIAL APPLICATOR PERMIT (FOR RECERTIFICATION).
